Tip Tax Credit Program Details

Eligible businesses can get a credit for certain Social Security and Medicare taxes (known as FICA taxes) that are paid on tips employees earn.

Tip Tax Credit allows eligible businesses to get back all the FICA taxes paid on tip earnings that surpass the federal minimum wage.



This translates to a credit for all the tips employees report.

Are my members eligible for this new program?

If your members operate a bar or restaurant, the eligibility criteria is straightforward.



✓ Tip-Driven Business

The services offered by the business, like serving or delivering food, should typically involve receiving tips from customers.

✓ Tips Documented as Wages

These tips should have been documented as wages, and the appropriate FICA taxes should have been paid on them.

As of September 2023, the IRS has put a temporary pause on accepting any new Employee Retention Credit (ERC) applications.

Adesso will continue to accept new applications, which will ensure you'll be in line to receive your refund when and if the program reopens.

Anticipated program relaunch: January 2024, however the IRS has not provided any definitive guidance.

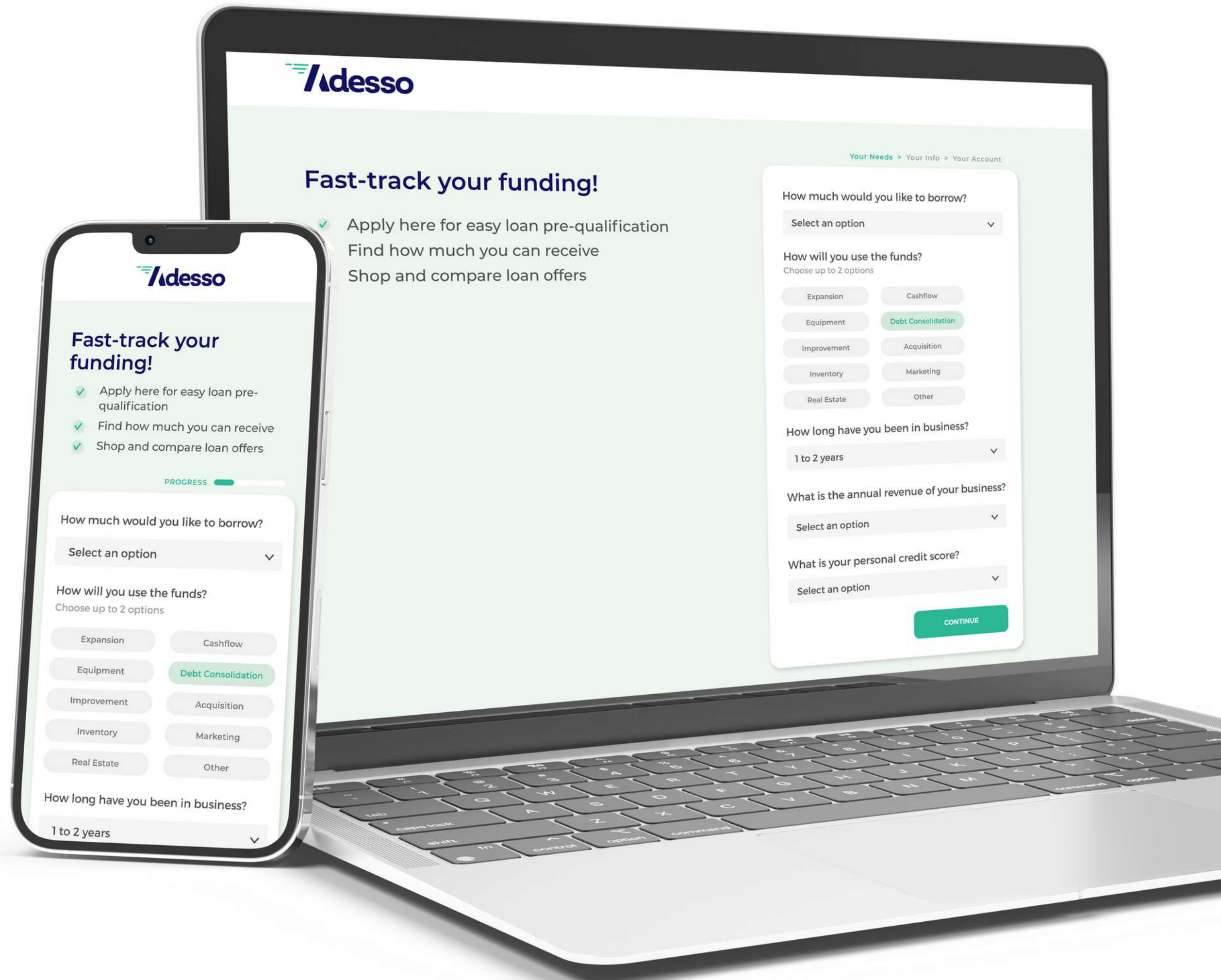

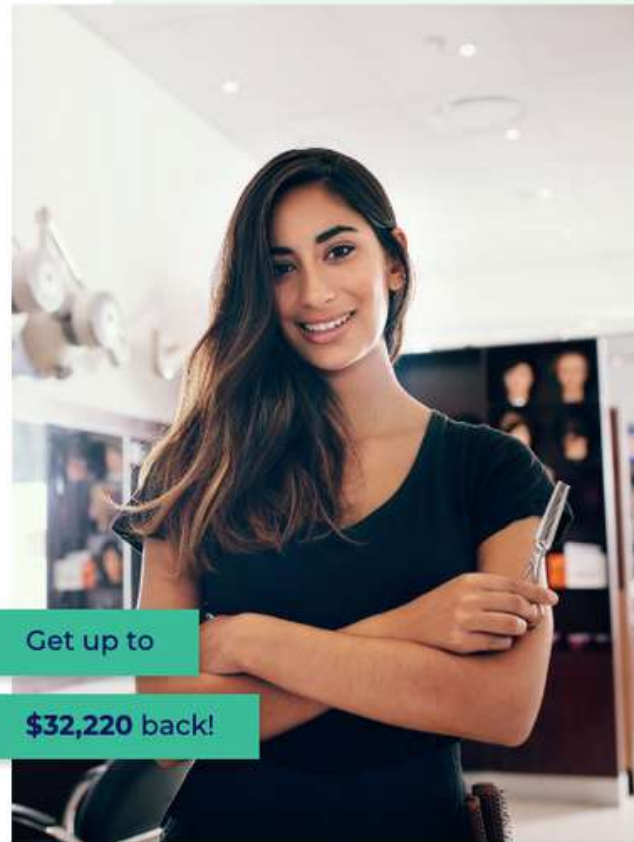
